

## Model Withdrawal Form

Note: The right of withdrawal only applies to consumers in accordance with Section 13 of the German Civil Code.

In accordance with legal obligations, the consumer participant will be informed that in distance selling (letters, catalogues, telephone calls, faxes, e-mails, via Mobile service sent messages (SMS) as well as radio and telemedia) according to the statutory provisions (§ 312g Abs. 2 Satz 1 Ziff. 1, 9 BGB) there is no right of withdrawal in regard to

- Contracts for the delivery of goods that are not prefabricated and for their Manufacturing an individual choice or determination by the consumer is relevant or clearly tailored to the personal needs of the consumer (No. 1)
- Contracts for the provision of services in the areas of accommodation purposes other than residential, transportation of goods, Motor vehicle rental, delivery of food and drink and for performance other services related to leisure activities if the Contract for the provision of a specific date or period (No. 9)

In the case of contracts for the provision of services in the areas of accommodation for purposes other than residential purposes, only the statutory regulations apply on the non-use of rental services (§ 537 BGB) apply (see CONDITIONS).

Insofar as services do not fall under the exceptions mentioned in paragraph 1, the Participants, insofar as this consumer is i.S.d. § 13 BGB, you may make use of your right of withdrawal. The Cancellation policy can be found at the bottom of the page by clicking on the link "Cancellation policy and cancellation form".

## Right of Withdrawal

You have the right to withdraw from this contract within 14 days without giving any reason.

The cancellation period is 14 days from the day on when you or a third party named by you who is not the carrier has taken possession of the goods. In order to exercise your right of withdrawal, you must inform me

of your decision to withdraw from this contract by means of a clear statement (e.g. a letter sent by post, fax or e-mail).

You can use this Model Withdrawal Form but this is not mandatory. To meet the cancellation deadline, it is sufficient for you to send the communication regarding your exercise of the right of cancellation before the cancellation period has expired.

## **Consequences of the withdrawal**

If you wish to withdraw from the contract, we will owe you all payments that we have received from you, including delivery costs (with the exception of the additional costs resulting from the fact that you have chosen a different type of delivery than the cheapest standard delivery offered by us ), immediately and at the latest within 14 days from the day on which we received the notification of your cancellation of this contract. For this repayment, we use the same means of payment that you used in the original transaction, unless something else was expressly agreed with you; under no circumstances will you be charged fees for this repayment. We may refuse repayment until we have received the returned goods or until you have provided proof that you have returned the goods, whichever is earlier. You must return or hand over the goods to us immediately and in any event no later than fourteen days from the day on which you inform us of the cancellation of this contract. The deadline is met if you send back the goods before the period of fourteen days has expired. You bear the direct costs of returning the goods. The costs are estimated at a maximum of around EUR 80.00. You are only liable for any diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics and functioning of the goods.
